## Relationship of the LIC & TLF

Following is a brief review of the relationship and roles of the LIC and TLF.

The two organizations are managed independently and staffed with volunteers, primarily from the LIC membership. The LIC is a non-profit social welfare organization that manages and operates the Historic Clubhouse and Marina. It accomplishes this with income from memberships, rental of the clubhouse, and marina fees. The LIC also pursues Grants from the County, State and TLF. Because the LIC is a 501 (c) (4) organization, it is not eligible for some grants permitted for 501 (c) (3) organizations, like TLF.

TLF is a non-profit charitable organization, affiliated with the LIC and supports six charitable causes. Students are supported from their time in Evergreen Elementary through academic or vocational higher education. Grant requests from likeminded KP non-profits are supported as well as the needs of the community, currently hunger being the greatest need. In addition, TLF responds to Grant requests from the LIC that align with its charitable purposes, such as the large grant obtained to protect the Marine environment and safety upgrades at the Marina; money to match the Preservation Grants for the Building upgrades; and money for Trail maintenance.

Donations to the foundation are tax deductible and deposited in reserved accounts per the donor's instructions. Monies in these designated accounts cannot be used for other purposes per IRS guidelines. The foundation currently has three fundraising activities to support these charitable purposes: a yearly Celebrate Campaign, a biennial Auction, and a biennial Super Sale.

Both organizations have basically the same mission, to Improve the South Key Peninsula Community, and we work together to accomplish this.
