Marsha Kremen, President, called the meeting to order at 7:00 p.m. There were no new members or guests.

Marsha introduced our guest speaker, Haley Nichols, the donor chair for the Peninsula Hawks Scholarship Fund. The following is an excerpt from her presentation:

Haley was a recipient of a scholarship in 1990, which is what attracted her to the Peninsula Hawks organization. She is now making an impact on other students' lives. Haley understands that education is a pathway out of poverty for kids on the KP, and strives to build the program every year. This organization was started in 1984, by a group of parents who saw a need for kids to know that their community supported them. Their mission is to connect kids with money for school. When choosing a scholarship recipient, donors not only look at students who plan to go to a four-year university, but also those interested in a two-year college, vocational school or of accredited program. types The Peninsula School District encourages who alternative students are on pathways.

The program started with \$7,000 in donations, and is now donating an average of \$280,000 a year with a goal of \$320,000 a year. Recipients of these scholarships are graduating seniors, who have taken at least six credits at Peninsula High school. Some criteria the donors look for when choosing a



recipient include athletics, career goals, volunteer activities, community service, performance academic and passion/interests. The program works on matching recipients to the donors' criteria. The donors give the organization the money to hold until the student starts college in the fall. Then, the money is distributed to the institution. or accredited school. There are several different types of scholarships: memorial scholarships, individual donors, employer matching, and community organization donors. Students receive an average of \$850, and the scholarships range anywhere from \$300 to \$8,000. Most money comes from private donors. The S.A.V.E. Thrift store is not only a great source of money for scholarships, but an opportunity for students to work and learn basic job skills as well.

Of the 300 plus graduating students, only half turn in a notebook, which includes letters of recommendation. two а transcript, statement of purpose, activities they are involved in and volunteer hours. This information can be used to apply for other scholarships as well. The teachers at PHS are very this supportive of program. On scholarship night, there are 175 students who attend and are eligible for a scholarship, and 80 donors who attend. \$180,000 is distributed from local donors. There are fifty students who are not picked for a scholarship, but the goal is for every student to receive a minimum of a \$500 scholarship.

If you are looking for a way to get involved, Haley states that they need volunteers who are not affiliated with a senior at the school, to read every notebook turned in by students, and then match about \$100,000 to recipients, based on the donors' criteria. There are many ways to get involved. The program needs committee members, readers, Winterfest volunteers, donors and thrift store volunteers. Here is their website: www.phsfund.org for more information.

Don Berger gave a scholarship update. Along with the academic scholarships we have been awarding to students, we will be adding vocational scholarships to the program. Because of this addition, the committee has expanded this year. The committee will determine the criteria that is used when picking a recipient, given that we are expanding our scope. They will work to determine a process of selecting the recipients, the amount of the scholarships given, and recurring scholarships. It will also need to be determined whether we make available the same amount of money for both the vocational and academic scholarships. Recommendations will be brought to TLF board, along with a budget, for approval.

Barb Floyd, TLF President, announced that Don Swensen, who is involved with the community council, will be joining TLF board.

Jan Pritchard, Student Programs Chair,



stated that many Evergreen Elementary students did not own a pair of rain boots. Twenty-four pairs of rainboots were given to these children in need. Jan stated that Big 5 gave us the sale price and an additional discount, so please thank them if you are in the store.

Haley stated that if any students need clothing or shoes, they should to go to their counselor to get a note, and visit the S.A.F.E. store, where they can shop for what they need, free of charge.

Randy Carr stated that one of our sponsors for the 2019 auction, Peninsula Light, asked if TLF would provide a presentation to show at their employee banquet. Tim Heitzman put together an amazing presentation with narrative and pictures. David Shinners worked on turning the power point presentation to a video, with music added. This allowed us to create another video, which we will show at our January meeting, showing our accomplishments from 2019. David showed Zeialer the video to the members.

Randy stated that everyone should have gotten a letter in the mail. Please remember to contribute to the 2019 Celebrate campaign.

BOARD REPORTS

<u>Secretary</u>: Kim Robinson asked that the minutes of the October meeting be accepted as written and submitted. MSP (continued on next page)

<u>Treasurer</u>: Jim Hettinger reviewed the October 31, 2019 Financial Report. We are \$25,000 over budgeted net income, through October, with two months left in the year. We are \$36,000 over net income budget for the year. Expenses are \$20,000. We are forecasted to come in \$20,000 over net income budget for the year.

<u>Membership:</u> Nancy Carr stated that membership dues are due. Forms are available here tonight, and she will take credit cards, cash, a check, or LIC bucks as payment.

Every table has a volunteer sign up for the Christmas dinner, on December 18th. The LIC provides the turkey and ham, but volunteers are needed to cook them. Volunteers are also needed to bring mashed potatoes, dressing and gravy. The rest of the food needed will be potluck items.

Please turn in your volunteer hours. This is very important. If you are turning in hours from the past, make sure you include the month that you volunteered. If you are having trouble with the Track It Forward site, please let Nancy know. Marsha stated that even if you are not going to use your volunteer hours for LIC bucks, it is important to document your hours. In order to get some of the grants we apply for, we must reflect the number of volunteer hours we put in as an organization.

Events: Bob Green stated that Trunk or



Treat was a wonderful event. He thanked the Beams for their efforts throughout the years in putting together the haunted house. Bob would like us to consider expanding our participation in coming years. The Greens went to the Gateway Park's All Hallows Eve Celebration. There were many activities such as a DJ, dancing, s'mores, and so much more. This was a wonderful community event.

There are lists available with volunteer opportunities for several approaching events.

Deck the Halls takes place on December 7th Denny and Jan Prichard are spearheading this effort. We need volunteers on the Friday before, to move decorations downstairs. There are signup sheets for Saturday. Lunch will be provided. This is our chance to get ready for our formal Christmas dinner, and for the Kids and Christmas event the following Sunday.

Kids and Christmas is on December 15th. Volunteer sheets are on the back table to sign up for a slot. We still have quite a few gifts from last year. Santa hands out gifts, there is a wrapping table, and the Girl Scouts will help with games and events. We are asking for wrapping paper donations. Over the years, the food has progressed from hot dogs, to chicken, to a turkey dinner. We served 300 people last year. We needed 12 turkeys, but now only need two, weighing (continued on next page)

at least 20 lbs. Coupons for a free turkey are available at Safeway or Albertsons when you buy \$100 in groceries.

Haley stated that these events are so important for kids that don't have much. She is speaking from personal experience.

Marina: Marsha stated that the board has been working on moorage rates, and members need to approve the changes that are in red, on the sheets at your table, this evening. Changes include the standard monthly rate for moorage, which will be \$7.75 a foot, special rates for some of the slips and rates for kayak moorage. No LIC bucks or discounts will apply for kayak moorage. The membership had a chance to review the changes. A motion was made to approve all moorage changes. MSP.

Robert Theisen stated that the back-flow valve which was missing, was reinstalled. Pierce County inspected the work, and the back-flow company tested it. All is approved. We are just waiting for the paperwork. This needs to be checked yearly.

<u>Newsletter:</u> Tanya Perry was not present, but Marsha asked that any articles you want in the newsletter be sent to Tanya by the 25th of the month.

<u>President:</u> Marsha Kremen stated that the pump-out station project is moving forward. Brett had a marine biologist and surveyor out to the marina last week.



The preservation grant from Pierce County, to do the survey for the new roof, has been approved. The project will start after the first of the year.

There was nothing to report this month from Building & Grounds, Trustee at Large, Historian, and Vice President.
